Admission Tickets

All stands upon receipt of payment will be sent trade stand admission passes and a vehicle pass.

4 m – 2 stand holders 6 m – 3 stand holders 8 m – 4 stand holders.

All stands 1 vehicle pass.

All additional vehicles and stand holders will be required to pay entry to the show.

All stand holders are responsible for providing the members of their staff, where applicable with the necessary tickets.

The positioning of Trade Stands is at the absolute discretion of the organisers, but consideration will be given to requests.

The sale of spray string or similar product will not be allowed at Campsie show.

If the show is cancelled, stand holders will be refunded.

All stands will be clearly marked with name of company/ plot number. Before setting up, please check with Trade Stand Convenors Charlie McIvor and Henry Braid where your plot is located.

No stand holder may occupy any space other than that allocated. All ropes and pegs must be contained within the boundaries of the stand.

Stand holders can access their stand from 7.30am to unload their goods. Thereafter no vehicles will be permitted on the stand after 9 am. All vehicles should be parked in the main car park.

No stands may be dismantled before 4.30pm.
